Adebabai Teshome, is Medical Doctor with master in public health and a PHD student at EUCLID University. He has more than 18 years public health and management experience in different countries including Ethiopia, South Sudan, Nigeria, India, Uzbekistan, Myanmar and Bangladesh. Over time, he has progressively grown from field level medical doctor to Medical Director and Country Director Positions for International reputed NGO's in different countries. He has designed and coordinated multiple health emergency responses including health system strengthening projects, vertical HIV/TB projects, and large-scale emergency health projects to diseases outbreaks, mass population movements, heavy metal poisoning and other natural and manmade disasters. Currently, he works for IOM South Sudan at a capacity of program coordinator for the Migration Health Unit.
